IMPORTANT REMARKS

- For everyone's security each rental and pitch has a maximum number of occupants (children and babies included).
- In July and August our rentals are from 15 h to 10h. In May, June and September arrival day is optional; minimum 2 nights stay.
- The camping sites are available from 12 h on arrival day. Departures are before 12 h.
- The campsite is not responsible for any theft or lost items.
- Pets must be kept on leash. Vaccination papers are compulsory. Dogs of 1st and 2nd categories are not allowed.
- Only one dog will be allowed per mobil-home.
- In July and August no arrivals are possible after 10pm. In May, June and September please contact us. For any late arrival please contact us in advance.
- No shorts are allowed in the swimming pool. Swimming trunks only.
- For your security the security bracelet must be worn at all times when within the campsite.
- Charcoal barbecues are not allowed.
- For rentals, sheets are compulsory in our rentals (not provided) and final cleaning not included.
- 1 vehicle per pitch.
- If you are under 18 years old you must be with a parent.

BOOKING CONDITIONS

- Only correctly completed booking forms will be taken into consideration.
- The campsite is not responsible for any objects left within its grounds. The campsite is not responsible for any damage or injury occurred on site.
- A booking will only be taken when sent with 25 % deposit.
- For rentals, the total amount of your holiday must be paid upon 30 days before arrival. For pitches, The total amount of your holiday must be paid upon arrival. You will receive (if the booking is possible) a confirmation of your booking.
- If when you arrive the number of occupants is different from the booking, your holiday price will be recalculated accordingly.
- No refund will be given for a late arrival or early departure.
- Your booking is held for 24 hours after your initial arrival date. (If you should delay your arrival please contact us). After this time your booking becomes void and you will not be refunded.
- Your rental is available from 15 h on your day of arrival ; (possible to arrive until 22 h if we are advised of this in advance). Departures are before 10 h for rentals.
- Your site is available from 12 h on your day of arrival ; 12 h for sites, (possible to arrive until 22 h if we are advised of this in advance).
- If you cancel 2 months before your arrival date your deposit will be refunded (except booking fee). If the cancellation insurance has been taken, see the extract of guarantees detailed below.
- Only registered campers and occupants can occupy the rented accommodation.
- Any legal claims must be made through the courts of Perpignan.
- All rental and pitch occupants must respect the campsite rules (available on request).
- Camping Le Pre Catalan reserves the right to keep and use for later publication any photograph in which you may appear.
- Civil liability insurance is compulsory

CANCELLATION INSURANCE

No refund will be given by the campsite itself if you leave early, arrive late or cancel outside of the delay mentioned above. However if you taken cancellation insurance please see the paragraph below.

EVENTS GIVING RISE TO GUARANTEE :

a - Seriousness illness, accident or decease:

- of the reservee or any other person expressly mentioned in the reservation agreement,
- of their spouse (or any person living cohabiting under the same roof),
- of their ascendants or descendants in direct line,
- of their brothers or sisters,
- of their sons-in-law or daughters-in-law,
- of their nephews or nieces (only in the event of death),
- of their substitute in the context of a liberal profession (on condition that the substitute has been provided for before subscription of the guarantee).

b - Substantial damages caused to the premises of the reservee, whether this is a professional or private lease, a principal or secondary residence, following a fire, explosion, flood or theft, arising in the 48 hours prior to the beginning of the stay or during the stay and necessitating renovation of the premises and the presence of the reservee on location during the period of the stay initially provided for.

c - Serious damages affecting the vehicle of the

reservee following an accident and arising in the 48 hours prior to departure and preventing the Insured from using it.

d - Modification of the dates of holidays, imposed on the reservee by the employer, arising after reservation of the stay and affecting the period of stay.

e - Redundancy of the reservee (or his spouse) on condition that the invitation to the prior interview is subsequent to reservation of the stay.

f - Transfer of the reservee (or of his spouse), at the initiative of the employer, involving a change of domicile, on the express condition that the notification is subsequent to reservation of the stay.

NATURE AND AMOUNT OF THE GUARANTEES

In the event of cancellation of stay, CORNHILL FRANCE shall reimburse the sums paid to the owner or his representative, and actually received, in accordance with the conditions of the initial reservation agreement.

In the event of interruption or delay of stay, CORNHILL FRANCE shall reimburse prorata the services invoiced and not used (subject to payment having been received). The insurance premium, the possible file costs and the costs and payments not included in the calculation of the premium shall under no circumstances be reimbursed.

A ceiling per loss of 3,800€, all taxes included, shall be applied in the event of cancellation, interruption or delay (see Appendix 09/2003).
